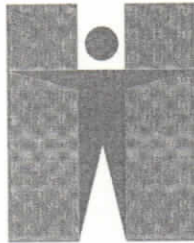

Importers and Exporters of Pharmaceutical Products

Dear Sirs/Madams,

Declaration of Flavouring Agents for Orally Consumed Products

To ensure pharmaceutical products imported into Hong Kong are free from Di(2-ethylhexyl) phthalate (DEHP), a new requirement is to be imposed for the application of import licence of all orally consumed products. With immediate effect, you are required to make declaration by completing the enclosed form with details of the countries of origin of any flavouring agents (including syrups) formulated in the orally consumed pharmaceutical products.

If the country of origin of the flavouring agent is from Taiwan, you are required to provide certificate of analysis showing the product is free from DEHP. The certificate of analysis issued by one of the laboratories recognized by Food and Drug Administration of Taiwan is acceptable.

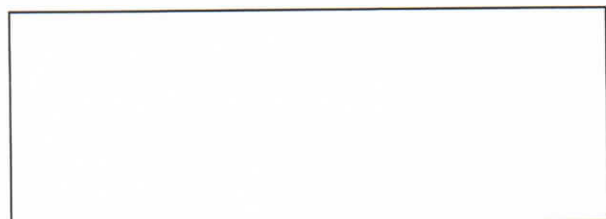
